NCLB Category A Offenses include: (1) firearm offenses; (2) aggravated assaults on another student; (3) assaults with a weapon on another student; and (4) assaults on a school district staff member.

The NCLB Category B Index takes into account the student enrollment and is based on the number of: (1) simple assaults; (2) weapons possession or sales (other than a firearm); (3) gang fights; (4) robbery or extortion incidents; (5) sex offenses; (6) terroristic threats; (7) arsons; (8) sales or distribution of drugs; and (9) harassment and bullying incidents.
